

When the resident applies for an exemption for dependents, etc. with regard to his/her non-resident relatives at the time of final tax return, the resident is required to attach "Documents concerning relatives", "Documents concerning visa for studying abroad", "Documents concerning remittances" or "380,000 yen remittance documents" to the tax return forms or present such documents when submitting the tax return forms.
