To file your 2024 income tax return

Filing an income tax return is the procedure in which a taxpayer calculates the amount of income earned during the year from January 1st to December 31st and the amount of income tax, then adjusts any excess or deficiency in withholding tax or estimated tax payments. In principle, tax returns for 2024 must be submitted between February 17, 2025 and March 17, 2025.


○To prepare your tax return on your computer
