Taxes Related to Living in Japan

Just like Japanese, Non-Japanese citizens under the following conditions must also pay taxes in Japan.

- ◆ Persons who earn income in Japan; As a rule, individual income tax is imposed on income.
- ◆ Persons who have a registered address in Japan as of January 1. Individual Inhabitant Taxes are also imposed.
- ◆ Consumption tax is also imposed when you stay at a hotel or eat at a restaurant, etc.

Individual Income Tax (National tax)

A tax imposed on personal income earned in a year starting from January 1 through December 31.

Individual Inhabitant Taxes (Local tax)

A tax you are obliged to pay to the prefectural and municipal offices with jurisdiction over your address as of January 1.

Consumption Tax (National tax)

The Consumption Tax at the rate of 10% (Standard tax rate) is applied to the purchase of goods and services in Japan. In the case of the purchase of food and drink excluding alcoholic drink and dining out, the rate of 8% (Reduced tax rate) is applied.

Tax on your automobile

Persons who have an automobile (engine size over 660 cc) or a light automobile (engine size is 660 cc or less) as of April 1, are obliged to pay "Automobile Tax" or "Light Motor Vehicle Tax", a tax reduction will be applied according to its engine size.

Property Tax (Local tax)

You are obliged to pay property tax if you have any land or buildings, etc. as of January 1 each year.
